In line with our company's long-term business plans and since our other printing facilities have sufficient capacity and we will also use contract printing options, it has been decided to terminate the printing operations of the İzmir DPC Branch located at Fatih Mahallesi Ege Cad. N 36 35414 Gaziemir Sarıç / İzmir as of 15.12.2022 in order to use resources more effectively and to increase efficiency.
